Confidentiality Agreement

Information concerning the management and operation of our organization is generally not known to the public and should be kept confidential. The following guidelines have been have been developed for this purpose.

Guidelines for protecting confidentiality

- Confidential information should only be shared with those inside the organization whose jobs require them to have access to the information or when the law requires or protects the release of such information.
- \triangleright Board Members, Employees, or Volunteers should not disclose sensitive or non-public information to people outside the organization or discuss it in public places.
- \geq Documents containing sensitive information- including information stored on computer systems- should be handled carefully and must be properly stored.
